1. **Welcome** by Shanna Anderson
2. **Minutes from previous meeting (January 25) approved via email.** There are 16 members of the community council. Fifteen approved the minutes and one abstained.
3. **Celebrations and Latest News.**
 - a. Brandy Westwood explained WIDA testing. WIDA is a series of tests that evaluate English language proficiency in the areas of reading, writing, listening and speaking. There were 225 students who needed to take the WIDA test. Only six students were unable to complete the test making about 97% completion. This is higher than the 91% district average. This success is mostly due to the efforts of Alex Post.
 - b. Jody DeLand explained the "Armpit Challenge" that faculty and staff have been participating in. She mentioned that the positive emails sent as part of the challenge has helped improve school climate.

- c. Bryan Leggat celebrated Literacy Night. Due to an error in advertising, there were only six students at the beginning of the event, but ended up with 150 people by the end. Everything went well and would like to do it again next year. Kudos were given to everyone involved.
 - d. Brandy Westwood mentioned that an author, Tiffany Rosenhan, will be visiting the school this Friday during Intervention time. All Language Arts teachers will be offering incentives for students to attend.
4. **Counseling** report by Jill Smith.
 - a. Students have completed their course requests.
 - b. Counselors are tracking 9th graders.
 - c. This week is College Week and counselors are doing games and activities to create college awareness. The focus for college is the idea of 1, 2, 4 or more.
 - d. The counselors are getting ready for 9th grade PCCR (Plan for College and Career Readiness) meetings. Students will meet in small group settings during WIN time. Parents are invited. Students who need credit recovery will meet individually instead of in groups.
5. **Principal's Report: TSSA Plan.** Bryan Leggat provided a handout and explained the TSSA Plan (Teacher Student Success Act). He had Cindy Horrocks explain what they do as instructional coaches. The goal is to help teachers improve so student learning will improve. Bryan mentioned that this year the coaching cycles have been optional, and next year they will be mandated. He also explained each item in the TSSA budget and mentioned that chromebooks will be purchased out of TSSA funds instead of Land Trust Funds.
6. **Trustlands Plan and Vote.** Bryan provided a handout listing proposals for the Land Trust Plan. The plan follows goals in the five areas of literacy, numeracy, credit recovery, professional development, and proficiency. The plan was discussed. ***MOTION: Lisa Dean moved "to approve the Land Trust Plan". It was seconded and approved unanimously.*** Bryan will formally put together the proposal and submit. Voting council members will receive an email where they can officially submit their approval of the plan. Bryan will also send a digital copy of the plan to Shanna who will send it to the community council.
7. **Calendar:** Handout was given and reviewed listing school activities for the next four months.
8. **Opportunity for Community Comments.** There were none.
