1.) School renews Edgenuity software for credit recovery. 2.) 8th graders that have demonstrated that they struggle to pass classes will be placed in the Study Skills class during quarter 1. 3.) As these students pass their classes, they have the opportunity to get out of the study skills class and into another elective. 4.) If students fail, they stay in this class to complete the credit recovery using Edgenuity. 5.) Other Freshmen are added to this class if they fail classes during the year. 6.) Study skills teacher will track their progress and report to the administration.

1.) Department members working with their department chairs will identify where their teams struggle based on data from school surveys and reflecting together. 2.) They will also receive guidance from our instructional coaches based on their observations. 3.) Teachers will look for professional development opportunities in order to enhance their tier one instructional practices. 4.) If necessary, teachers will get substitute coverage if they have to miss school to attend. 5.) Administration will also purchase a book for each teacher to read to help them in the classroom.

For years we looked simply at passing rates for our students. We noticed that most of our students passed all of their classes, so we wanted to next determine at what depth their proficiency was in their classes. In 2021, the average proficiency rate was a 2.4, and in the current year it has jumped to a 2.6. We are hoping to continue this trend of a higher level of proficiency by setting the 2022-2023 goal as a 2.8 for the year.

Making a significant change in proficiency will require not only some of the elements from earlier goals (above), but the addition of support professionals who will be working with students to improve their grades. 1.) We will hire two Learning Lab aides to help students who are behind with their current grades. 2.) Next we will hire a Catch-Up aide to help students during lunch with their missing assignments. These professionals will provide essential support for our struggling students throughout the year.
